SUBJECT: MARINE PARK RESTROOM

DATE: SEPTEMBER 3, 2024

During its August 6, 2024 meeting, the Commission heard public testimony from a Marina moorage tenant expressing concern and dissatisfaction with the newly restricted access to the Marine Park Commercial Building restrooms due to the new private leases for Ixtapa Restaurant and JettyLight. The Commission directed staff to evaluate cost-effective options for providing a new flush toilet/sink facility to serve the eastern side of the Marine Park.

Operations Manager Parker Nelson has determined that a sewer line connection is available nearby the Marine Park Commercial Building that would provide relatively simple connection to the existing sewer infrastructure and the newly installed sewer lift station pumps. This location is across the Sacagawea Circle access road to the west of the Marine Park Commercial Building parking lot, at the east end of the Marine Park Green (see map below).



Staff requested cost quotes from CXT, Inc., who is the provider of the new prefabricated restroom and shower facility that will be installed at the new Harvey

Road parking lot and provide these facilities via a pricing agreement with the state of Oregon.

Attached are three of CXT's smallest and lowest cost models, with costs ranging from \$78,990 to \$116,622 including delivery but not including sewer/utility hook up.

The Port may be able to secure a Local Government Grant Program grant to fund up to 80% of the project costs. The next application round will open in January 2025, due in April, with award notifications typically not happening until September. So, if the Commission chooses to rely on this funding the restroom would not be installed until spring of 2026. If the Commission prefers to self-fund the project, CXT has a 180-day delivery guarantee after the finalized order is received, which would enable the Port to install the restroom in late spring of 2025, provided permit approvals are received in a timely manner.

Commission direction is sought on how best to move forward on this issue.

Recommendation: Discussion.





Introduction:

The Mid-Columbia Economic Development District (MCEDD) is requesting the Commission's approval to send a letter of support as they coordinate to apply for a number of grant applications to the Oregon and Washington Departments of Transportation.

MCEDD's draft letter lays out a number of efforts, comprising a collective regional vision for a coordinated transit system that was developed in the 2023 Gorge Regional Transit Strategy. This letter will be sent alongside other similar letters from regional partners to bolster MCEDD's grant applications. MCEDD has tailored the draft letter to reflect the Port's recent toll waiver for Skamania County Transit.

The ODOT's Statewide Transportation/Improvement Fund Discretionary/Statewide Transit Network Grant Program provides a dedicated source of funding for improving, maintaining, and expanding public transportation for all users. Every two years, public transportation funding is made available to support access to jobs, improve mobility, relieve congestion, and reduce greenhouse gas emission in Oregon. Two years ago, the Port was a signatory to a similar letter of support.

WSDOT's Consolidated Grant Program provides funds for public transportation improvements within and between rural communities; tribal transportation; transportation services between cities; purchases of new buses and equipment; and public transportation services to seniors and people with disabilities.

By signing this letter, the Port can contribute to the development of a coordinated regional transit system and support the economic growth of the region.

Staff recommends that the Port Commission approve the signing of the letter of support for MCEDD's grant requests. This action aligns with the Port's goals of promoting regional transportation and economic development.

Introduction:

KiddieCity is seeking funding to construct and renovate a new childcare facility in Cascade Locks, Oregon. The facility would be located in a vacant/ underused space within Cascade Locks Elementary School.

KiddieCity, LLC is applying to the Oregon Childcare Infrastructure Fund (CCIF) program to fund construction/renovation costs. The CCIF Program is a competitive statewide grant program focused on providing funds for the establishment, expansion, and improvements of childcare facilities across the state. The program was created in the 2023 Oregon Legislative Session.

Pending the school district's approval, KiddieCity plans to request approximately \$100,000 to fund renovations and create at least 40 new daycare slots. The facility would include an infant room and a large room for "wobblers" and toddlers.

This would be KiddieCity's third location in the Gorge and the only daycare facility in Cascade Locks. The closest daycare facility is across the river in Stevenson, Washington. Access to early childhood education and daycare is a significant challenge for local and regional economic development.
