


PLAN COMES FIRST, THEN PROJECT

- New PCT amenities





Goal 2: Facilitate Economic Development Through Strategic Management of Port-Owned Buildings and Land

- Feasibility study for optimal uses of Port-owned lands.
- Development of comprehensive land use plan, exploring rezoning possibilities
- Possible Flex 6 modifications for better marketability
- Facilitate multi-jurisdictional, multi-sectoral partnerships for land development collaboration.
- Feasibility study for development of Port-owned residential land, affordable housing development.
- Acquisition and redevelopment of vacant buildings and properties within the downtown core.





- Capital improvements for event rental facilities.




